## The Early Warning system is a free service from the NCSC

As care providers, you rely on digital systems every day – to store care plans, communicate with families, manage medication records and more. But these systems are increasingly being targeted by cyber criminals. That's why the National Cyber Security Centre (NCSC) offers a free service to help protect organisations like yours: the Early Warning system.

## Data Security Protection Toolkit (DSPT) – publish before June

The <u>Data Security and Protection Toolkit</u> (DSPT) helps adult social care providers in England to check and improve how they keep people's information safe. It is the official self-assessment tool for the care sector and is widely recognised by CQC, local authorities and the NHS.

The DSPT will help you to comply with: UK GDPR, commissioners' data management expectations, and CQC's new Single Assessment Framework under "Well Led" Governance, management and sustainability.

And it can open up new business opportunities. You must have an up-to-date DSPT if you deliver or wish to deliver services under NHS contracts, access NHSmail or take part in any healthcare record sharing projects such as GP Connect.

Care providers must review, update and republish their toolkit assessment at least once every year, otherwise it goes out of date and it is invalid. We recommend that this is kept up to date throughout the year, especially if providers have introduced new systems or services. Providers can make changes to toolkit questions and republish at any time throughout the year. However, the toolkit does have to be published *at least* once every toolkit year. **The updated DSPT for 2024-25 is now available** – so it is a great time to complete your DSPT assessment. ## **BLMK ICS updates**

Supplying local care homes with chairs to lift residents after a fall saves staff time and reduces ambulance call-outs

Bedfordshire, Luton and Milton Keynes Integrated Care System Digitising Social Care programme and Felgains Ltd'

A chair which can be assembled around a fallen resident to lift them safely and quickly in an emergency after a fall has been proven to reduce avoidable ambulance callouts and associated healthcare costs, improve care, and free-up staff time for other caring duties.

Following an initial pilot, the Digitising Social Care programme at Bedfordshire, Luton and Milton Keynes Integrated Care System provided 174 Raizer chairs to local care organisations – mostly residential care facilities and nursing homes.

The findings confirm a number of benefits and an impressive return on investment:

- Improved resident wellbeing and dignity
- More efficient use of staff time
- Fewer avoidable ambulance callouts and trips to hospital
- Fewer avoidable hospital admissions
- Enhanced staff satisfaction.

## Review & republish your DSPT

Because things change, you need to review and republish your toolkit every year so that it reflects your current data and cyber security arrangements. For example, you may have introduced new staff, data systems, technology or services – which in turn will impact on how you manage your information.

This webinar is for care providers who have published before and are reviewing and republishing their DSPT. It will cover what has changed within the Toolkit for 2022/23, as well as how to:

- Login to your DSPT account
- Review your DSPT including what is different if you were previously published at Entry Level or Approaching Standards
- Complete to at least Standards Met
- Publish your DSPT standard
- Access free, official support from the Better Security, Better Care programme.
